Summary Report:

The orientation programme was conducted with the aim of sensitizing the multiple sectors and the stake holders regarding the Nutrition Plan. The MSNP orientation programme was fruitful. This orientation provided the overview about MSNP to all line agencies and stakeholders. It sensitized that coordination and commitment from all the line agencies and stakeholder plays an important role in MSNP implementation. The feedbacks from the participants were delivered to the respective agencies and the confusions from the stakeholders were addressed accordingly.

MSNP orientation and planning workshop was organized by Child Health Division with the support of DDC and MSNP district support team/HERD for district line agencies and stakeholders of Multi sector Nutrition Plan. DDC as well as other district line agencies have well idea about MSNP. So, the main objective of this orientation was to provide overview of MSNP and Program planning of respective line agencies for this fiscal year.

Specific objectives of the program were:

- To notify different sectors about the multi sector nutrition plan
- To enhance knowledge on overall nutrition and MSNP.
- To bring out efficient and effectiveness in the program activities along with developing appropriate skills.
- To develop common understanding on the roles and responsibilities of different stakeholders/ line agencies engaging in MSNP.
- To create sectorial commitment on MSNP implementation in district level.

ORIENTATION PROGRAMME- A brief Report

There were 76 participants in the orientation programme. Representatives from district line agencies (sectorial office chief and MSNP focal person), stakeholders of nutrition including NGOs/INGOs, and MSNP team of HERD were participated in the orientation.

The orientation program began with the chairmanship of Local Development Officer; Mr. Jagannath Panta. The chief guest of the orientation programme was the Chief District Officer; Mr. Pradip Raj Kandel. Mr. Puskar Ghimire (Program Officer; DDC) who was the master of the ceremony, expressed his warm welcome to all the participants and the guests. The session started with the objectives of the orientation programme which was delivered by Mr. Pravakar Jha from DHO. The programme had a very good aspect of the orientation programme as it started its technical session with the distribution of nutritious foods to a breast feeding mother with the aim of awaring every 1000 days families regarding the diet a mother needs to intake. After the introduction session of all participants, the technical session was started.

During the technical session Mr. Raj Kumar Pokharel; the Chief of Nutrition Section (Child Health Division), began his presentation with the briefing of the current situation of stunting, underweight and wasting in Nepal. He also shared the importance of Nutrition in all sectors, aims of MSNP, Malnutrition in Nepal, Causes of Malnutrition and highlighted interventional programmes which included both nutrition specific and sensitive indicators. Nutritional status can be improved with the multi sector approaches and the health sector is not the only one responsible factor. Mr. Pokharel highlighted that the Nutrition is both ART and PART of life. He also shared how the districts were selected, its criterias and all the district level activities that is expected. Mr. Pravakar Jha again presented the nutritional status in Sarlahi district where he expressed demographic status (total population, immunization status, breast feeding status) and highlighted that there are 285 Severe Acute Malnutrition Cases that have been recorded in the HMIS till date. He also exhibited the activities that have been conducted by the DHO Sarlahi.

Mr. Pradip Raj Kandel, Chief District Officer, detailed different line agencies and requested for immediate actions from every agencies in planning process. He also wanted all the information systems of different sectors to be updated as soon as possible. Mr. Jagannath Panta, Local Development Officer presented about the roles and responsibilities of district line agencies in MSNP coordination and effective implementation. He highlighted the situation of the district and discussed that MSNP is more focused on integrated approach with integrated programme, integrated training, integrated publicity and integrated monitoring and supervision to improve the nutritional status of 1000 days mother and children. He remarked that the common understanding about MSNP, commitment and ownership, capacity development, continuous reporting, joint monitoring and evaluation, resource management are some of the challenges of MSNP. He also shared the responsibilities of each line agencies in MSNP implementation. Lastly, he concluded with the expectation he bares with the efforts from all the line agencies and stake holders in MSNP programme and the active participation in the DToT which was going to be held the very next day onwards for 4 days.

Conclusion

The MSNP orientation programme was fruitful to bring all concerned stakeholders in a single platform and discuss about effective implementation of MSNP. This orientation provided the overview about MSNP to all line agencies and stakeholders. It sensitized that coordination and commitment from all the line agencies and stakeholder plays an important role in MSNP implementation. There were some technical errors which were soon solved and made sure that the training session would not face those problems. The feedbacks from the participants were delivered to the respective agencies which was the good part of the programme.
