Mr. Amrendra Ray (DC, MSNP) expressed his warm welcome to all the participants and the guests. The session started with the objectives of the programme which was delivered by Mr. Ray. After the introductory session of all participants, the technical session was started.

A thorough information regarding MSNP was delivered by Mr. Ray. Mr. Ray, capturing everyone's attention briefly highlighted the criteria of VLNFSSC members as per norms of MSNP. He also explained the committee's responsibilities towards MSNP goals.
